### Special Additional Conditions:

The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

The industries shall take all efforts to use and popularize “Mission LiFE” logo and mascot which is available in TNPCB & MoEFCC website. They shall also request their employees to adopt “Mission LiFE” action points and document the same and furnish half yearly report to Board.

### Additional Conditions:

1. The unit shall treat and dispose the sewage through septic tank followed by Soak pit.
2. The unit shall completely recycle the trade effluent as reported.
3. The unit shall dispose the solid waste regularly without any accumulation.
4. The unit shall maintain a good housekeeping.
5. The unit shall comply with the provisions of Plastic Waste Management Rule 2016 as amended.
6. The unit shall not manufacture and use Single Use Plastic banned items such as “Plastic sheets/cling film used for food wrapping , Plastic sheets spreading on dining table, plastic thermocol, plate, plastic coated paper cups, plastic coated paper palates plastic tea cups, plastic tumbler, thermocol cup, plastic coated carry bag of all size and thickness, Non oven carry bag of all size and thickness, water pouches, plastic straw, plastic flag, ear butts with plastic sticks , plastic sticks for balloon, candy with plastic sticks , ice cream plastic sticks , polystyrene for decoration, cutlery shuch as , plastic fokes , plastic spoon, plastic knife, packing or wrapping of sweet box invitation card, cigarette box, PVC banner less than 100 micron, plastic stirrers and plastic tray” as per Go(Ms) No.37 of Environment and Forest department dated.05.06.2020 2020 , GO (MS) no: 84 Environment and Forest(EC2) Department dated 25.06.2018 and CPCB Direction No.B.17011/7/UPC-IIPWM(SUP)/2022 dated:30.06.2022
7. In case of revision of consent fee by the Government, the unit shall remit the difference in amount within one month from the date of notification. Failing to remit the consent fee, this consent order will be withdrawn without any notice and further action will be initiated against the unit as per law.
8. The Consent order is issued based on the documents furnished by the applicant. In case any documents found to be incorrect/not in order at a later date the consent order issued to the project will be deemed to be revoked/cancelled.
